I have filed an intake complaint and met with a Legal Intake Counselor. My options were discussed with me and I had an opportunity to ask questions. I understand the following:

- 1. Before any charge is filed, my intake complaint must be reviewed and evaluated by a prosecutor.
- 2. If a criminal charge is approved by a prosecutor and filed, there will probably be a warrant issued. This means that the person I filed a complaint against will probably be arrested.
- 3. If a criminal charge is approved by a prosecutor and filed, I will be required to come back to court several times. If I am subpoenaed and fail to appear, I can be held in contempt of court.
- 4. Once a charge is filed, I do not have the right to have the charge dismissed. I have the right to participate in the case, but decisions regarding the outcome of the case will be made by the prosecutor and/or judge.
- 5. What types of protection orders may be available to me.
- 6. If any children were abused or neglected or were at risk for abuse or neglect, the Legal Intake Counselor is required by law to give that information to Franklin County Children Services.
  - 7. If requested, a domestic violence advocate is available to speak with me.



Narrative

On Friday, July 22, 2016 at approximately 2:40am, Officer Ricks #1546 and Officer Erdenberger #2688 were dispatched to 29 E. 3rd Ave. on a domestic violence incident. The caller said her boyfriend hit her and she had bruises. The caller said the suspect was still at the house.

Upon arrival, Officers Ricks and Erdenberger made contact with the caller, Tiffany Thompson, who was later identified via her OH driver's license. Ms. Thompson said on Saturday, July 16, 2016 she and the suspect, Ms. Thompson's boyfriend, Ezekiel Elliott got into an argument about their unhealthy relationship. Ms. Thompson said she and Mr. Elliott lived together for about 3 months from November 2015 until January 2016. Ms. Thompson and Mr. Elliott were at Mr. Elliott's Watermark apartment, 1860 Canvasback Lane Apt. 4 on Saturday. Ms. Thompson said they got into an argument hecause Mr. Elliott cheats on her all the time and when they had broken up for a bit and she slept with another guy. The gument turned physical and Mr. Elliott attempted to hit Ms. Thompson in the face. Ms. Thompson said she raised her right arm to cover her face from the strike. Ms. Thompson had a bruise on her right forearm. That was the end of the fight and argument on Saturday.

On Sunday, July 17, 2016, Ms. Thompson said a fight between her and Mr. Elliott started because they went out to different places and Ms. Thompson did not make it home before Mr. Elliott. Mr. Elliott choked her leaving a red mark and bruise on her neck.

On Monday, July 18, 2016, Ms. Thompson said she remained at the Watermark apartment with Mr. Elliott's friend while Mr. Elliott went out. Ms. Thompson said when Mr. Elliott returned to the apartment he picked Ms. Thompson up and threw her against the wall. Mr. Elliott told Ms. Thompson she was lucky that he has not killed her yet.

Ms. Thompson said on Tuesday, July 19, 2016, she and Mr. Elliott did not fight. Ms. Thompson said Mr. Elliott cried and told Ms. Thompson he loved her and did not want to have to put his hands on her but "it's tough love."

Wednesday, July 20, 2016, Ms. Thompson and Mr. Elliott went to 4th Street Patio. Ms. Thompson said everything was fine until they got home and she asked him a question. Ms. Thompson could not remember the question she asked that set Mr. Elliott off. Ms. Thompson said Mr. Elliott "lost it" and picked her up under her arms, in her armpits, and threw against the wall. Mr. Elliott then grabbed her throat. Mr. Elliott released her neck and grabbed her left wrist and drug Ms. Thompson across the floor leaving rug burns on her right knee.

Mr. Elliott said he has never lived with Ms. Thompson. Mr. Elliott said he has never laid a hand on Ms. Elliott and the bruises on her body were from a fight she had gotten in at a club called Social. Mr. Elliott did admit that he was a cosigner on a vehicle loan for Ms. Thompson. Mr. Elliott also admitted he pays the rent for Ms. Thompson's apartment in Dublin, OH.

Due to the conflicting variations of what happened and whether or not Ms. Thompson and Mr. Elliott had ever lived together, no charges were filed against Mr. Elliott. Ms. Thompson was referred to the Prosecutor's Office to discuss filing charges against Mr. Elliott.

Ms. Thompson completed a written witness statement.

jt. Morrow #5292 responded to scene and took 15 pictures of Ms. Thompson's injuries, the scene at the time of Ms. Thompson's call and the associated photo card.

I am friends with Ezekiel Elliott ("Mr. Elliott") and Tiffany Thompson ("Ms.
 Thompson") and have personal knowledge of their interactions during the week of July 16, 2016 to July 23, 2016.

#### Saturday July 16, 2016

- On Saturday, July 16, 2016, I traveled from Dallas, Texas to Columbus, Ohio with Mr. Elliott.
- 3. At the airport we were greeted by Ms. Thompson and she subsequently drove us to Mr. Elliott's Apartment ("Apartment") located at 1860 Canvasback Lane, Columbus Ohio.
- 4. When we arrived at Mr. Elliott's Apartment at approximately 2:00 p.m., Mr. Elliott, Ms. Thompson and I stayed at the Apartment until we went to the Social Room ("Social Room") that evening. The Social Room is located at 527 North Park Street, Columbus, Ohio.
- 5. Mr. Elliott, Ms. Thompson, myself and another friend left the Social Room at approximately 2:30 a.m Sunday morning. The four of us went back to Mr. Elliott's Apartment and we stayed at the Apartment until approximately 3:30 a.m.
- 6. At approximately 3:30 a.m., I left the Apartment to go stay at another friend's house.

At no point did I witness any altercation between Ms. Thompson or Mr. Elliott. I also did
not see any evidence of injury, bruising, or scrapes on Ms. Thompson at any point on
July 16.

#### Sunday July 17, 2016

- On Sunday, July 17, 2016, I returned back to the Apartment at approximately 11:00 a.m. to see Mr. Elliott and Ms. Thompson.
- When I arrived, Ms. Thompson and Mr. Elliott were in a good mood, happy and playing
  with Mr. Elliott's dogs. Throughout the day, Mr. Elliott, Ms. Thompson and I stayed at
  the Apartment.

- 20. Ms. Thompson had accidently locked her keys in the car and wanted to try to get them so she could go back to her own apartment since Mr. Elliott was not there.
- 21. I encouraged Ms. Thompson to come inside and stay at the Apartment as I did not believe she was in any condition to drive home.
- 22. Ms. Thompson eventually came inside the Apartment and then called another male to come and pick her up. When the car arrived, I walked Ms. Thompson to the car and there were males that I recognized in the car. Ms. Thompson did not get in the car and came back inside the Apartment with me, we talked for a while and then went to sleep.
